Implementation Process

US physician may use a virtual platform (a mobile app, smart devices or recorder) to communicate with their medical scribe in real-time. Our scribes work virtually in a HIPAA-compliant environment. Our scribes understand the preference of their physicians and create a precise chart note with more than 95% accuracy and upload it directly into the EHR. EHRs are populated with both discrete and non-discrete data elements. Providers subsequently review and sign completed charts.

Our Medical scribes can communicate with their Providers either synchronously or asynchronously, as per their preference. They take notes from doctors and act on them in real-time or via an audio recording.

Our virtual assistants are also capable of capturing dictations with great typing speed, in case the provider wants their scribes to create a plan in their words. Similarly, practitioners can emphasize if they wish to disregard something for charting purposes



Medical Scribe Assignment

Dedicated scribes with domain-specific knowledge of the specialties are assigned to doctor's. This approach ensures consistent staffing and shortens the learning curve for both providers and scribes. As a result, the assigned remote medical scribes learn the provider's charting preferences and documentation style in less time frame.
